Notes from Paula's Lessons learned around the shop (and Darrell's Irrigation class notes)

Last month we talked about things to consider as you get ready to install your irrigation system. This month here are a few steps to take as you begin your installation:

• Call for utility locators to come and mark underground wires and pipes before you dig-

- Consider the lay and quality of your land: slopes, drainage, clay, sandy, or rocky, etc.
- Determine your water pressure and flow from the source to your new system
- REMEMBER, plan well, measure everything 2x and bring your drawn out sketch to AQS Supply and have Darrell help you make a list of everything you will need and get you started with supplies such as: flags, pipe, valves, controllers, couplings, sprinkler heads, wire, etc.
- Have a plumber tap the water meter unless you are sure that you know what you are doing. Use a plumber, he/she will be licensed and insured.
- Set out flags for each head and valve location
- Save the indoor work for rainy days
- Start laying out and building the system from the extremities to the water source
